We collect the details and information provided by the User, with the assistance of such information we learn about you and about the requirement of our services for your business and your visits to our Website and other websites accessible from them, to provide more effective services, and includes all information that can be linked to a specific individual or to identify any individual, such as name, address, mailing address, telephone number, email ID, physical, physiological, sexual orientation, and payment method and transaction details.
